CLAM Board Structure and Nomination Process 2017

A Primer on Community Land Trust Board Structure

As a Community Land Trust that creates affordable homes in West Marin with community voice, CLAM has a board structure that allows for and preserves a balance of interests. This tri-partite structure is a hallmark of Community Land Trusts across the country. The three parts, or categories, of CLAM board structure include a) those who stand to directly benefit from CLAM's work in the community, b) general members from the community, and c) persons with specific sets of expertise that CLAM needs.

Below is a listing of CLAM board members and open slots per category. While CLAM strives to preserve a balance of board members in each category of board structure (ie, Lessee, General Member, and Public Representative), the actual number of board members occupying each category is also dependent on the nomination process, and individuals able to serve.

While persons who fall within the definition of each Board category nominate people for that specific category (further described below), the entire CLAM membership votes on the board slate at the Annual Meeting.

Categories of Board Representation and Nomination Process for Each Category

Resident or "Lessee" Member Category

This includes anyone who rents or owns a CLAM Home, any CLAM member who rents in CLAM's service area of West Marin (Tomales, Marshall, Point Reyes, Olema, Inverness Park, Inverness), or any CLAM member who holds a position to represent the interests of those who would benefit from a CLAM home (example: school personnel, community service staff, healthcare staff, etc). If you fall into this category as a CLAM member, you can nominate yourself or other persons who fall into this category to serve on the Board.

General Member Category
